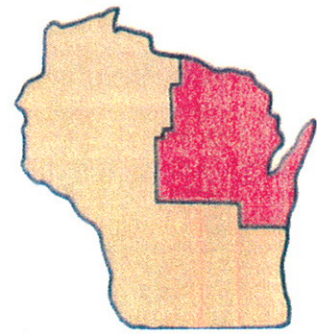

BIANEW Minutes January 08, 2009

The January 2009 BIANEW meeting was called to order by President Dennis Jensen at 9:30 AM. The morning presentation was Archie Laundremann of Woodworks.

Woodworks is a organization providing design specifications for wood products engineering in non-residential applications. The second speaker of the morning was Ben Rosen of Maxxon Corporation who gave a presentation on sound control in commercial construction and how to meet the requirements of the commercial building code through proper sound proofing. The third speaker in the morning session was Rex Swenson of Woodworks. His presentation was on shear wall construction and the inspection of them. The AM programs were approved for 2-hours of continuing education credit in both UDC & commercial construction inspection.

The afternoon business meeting was called to order by President Dennis Jensen @ 12:55 PM. Treasurer Rob Cormier gave a treasurers report which was approved by the group. Leroy Stublaski of the Wisconsin Department of Commerce reported that there is a public hearing to be held on the requiring that all building subcontractors be required to hold a qualifiers credential. He also reported that the new 2009 UDC Code Book will be provided at the 2009 Winter Code UDC Updates.

A motion was made that BIANEW pay the registration fee of all members attending the 2009 League of Municipalities Building Inspectors' Institute. This was seconded and approved by the group.

New Business: Dennis Jensen expressed that BIANEW start a committee to assist in the forming of the FEMA Emergency Inspector's Pool. Steve Dunks was assigned to this project and he will report further information on this at our March 2009 meeting. A round table was held. The meeting adjourned @ 1:30PM.
